## **GENERAL TERMS AND CONDITIONS OF SALE**

1. All sales, deliveries and services by Lotto Zesdaagse Vlaanderen Gent are subject to the following terms and conditions. These terms and conditions prevail over terms and conditions of the customer that have a different and opposite purpose, even if the present terms and conditions are introduced later. The present terms and conditions are deemed to have been accepted by the customer, unless the customer lodges a protest in writing, stating his reasons, within 5 calendar days after receipt. Nullity of one of the current stipulations will not affect the validity of the other stipulations.
2. The customer can only cancel orders in writing. Cancellation will only be valid after written confirmation by Lotto Zesdaagse Vlaanderen Gent.
3. Our invoices are payable at our place of business, net, without discount, within 30 days after the invoice date, except when the invoice states otherwise. Every invoice that is still unpaid on the set due date will incur an automatic interest surcharge at a rate of 12% per annum up to the moment full payment is received, without proof of default being required, where part of a month is considered a full month, with a fixed indemnity of 10% of the invoice amount, and a minimum of EUR 60.00 per invoice. Failure to pay the invoice amount of one single invoice by the due date, renders the outstanding balance on all other invoices, even if their due date has not passed yet, automatically payable with immediate effect.
4. The customer hereby irrevocably and extraordinarily accepts and acknowledges that any delivered items remain the property of Lotto Zesdaagse Vlaanderen Gent until the purchase price, made up of sum total, costs and interests, has been paid in full.
5. If Lotto Zesdaagse Vlaanderen Gent is unable to execute an order it has accepted, or is unable to do so within the set delivery term, due to causes beyond its control or force majeure, Lotto Zesdaagse Vlaanderen Gent will be entitled to terminate the contract without being liable for compensation for damages.
6. Freight and packaging costs will fall to the customer. The customer will bear the risk and cost of all transports, regardless of whether they are taken care of by Lotto Zesdaagse Vlaanderen Gent itself or a haulier. Storage of goods delivered and manufactured by Lotto Zesdaagse Vlaanderen Gent as well as the customer's own goods, be it on the premises of Lotto Zesdaagse Vlaanderen Gent or at third-party premises, will be at the risk of the customer, who will therefore have to take out adequate insurance to cover any possible damage instances.
7. Lotto Zesdaagse Vlaanderen Gent cannot, barring cases of intent, be held liable when execution of an accepted sale, delivery, service cannot be completed on time, or cannot be completed at all, due to an error committed by its agents, subcontractors or due to an error by the customer. Lotto Zesdaagse Vlaanderen Gent's liability for any kind of direct or indirect damage in the execution of an order it has accepted, barring cases of intent, is always excluded. If Lotto Zesdaagse Vlaanderen Gent were to be held to pay any kind of damages, for whatever reason, then these will always be limited to the amount of the proven direct damage, excluding all other amounts. Compensation for damages will never exceed the price agreed in the agreement.
8. In order for a complaint regarding deliveries, services and/or invoices to be valid, it has to be lodged in writing within three days after the delivery, service provision, receipt of the invoice or discovery of any kind of fault, by way of a registered letter to Lotto Zesdaagse Vlaanderen Gent. Failing that, delivery, service or invoice will be deemed to have been accepted by the customer.
9. In the event of printing work, the customer will have to take care of copy editing. As soon as the customer has sent a document that is 'ready for print' Lotto Zesdaagse Vlaanderen Gent will be relieved of any liability in the event of errors or omissions detected after printing. In the event a proof cannot be produced due to time restraints, the customer will assume the incurred risk.
10. Lotto Zesdaagse Vlaanderen Gent cannot be held responsible for claims related to manufacturer trade marks, models, drawings, licences and/or other intellectual, industrial or related property rights, filed by third parties for orders executed by Lotto Zesdaagse Vlaanderen Gent for customers ...
11. Trade marks, models, drawings, licences and/or other intellectual, industrial or related property rights that are held by Lotto Zesdaagse Vlaanderen Gent, will remain the property of Lotto Zesdaagse Vlaanderen Gent and can only be used by other parties with the prior written consent of Lotto Zesdaagse Vlaanderen Gent. In the event of breach of this article, Lotto Zesdaagse Vlaanderen Gent will automatically be entitled to a fixed compensation of EUR 5,000 per breach, without any proof of default being required, and without prejudice to its right to file a sustainable higher claim.
12. The customer gives Lotto Zesdaagse Vlaanderen Gent the right to, whenever this is deemed useful, state its capacity as the publisher on every copy of the executed order. Lotto Zesdaagse Vlaanderen Gent reserves the right to print its name and/or logo on every creation or reproduction.
13. The customer will hereby consent to Lotto Zesdaagse Vlaanderen Gent gathering all personal data exchanged by the parties as part of their relation, and storing it in a database for commercial administrative purposes, and with an eye to direct mailing. The customer will ensure that all legal formalities have been performed, and that all persons involved will be granted the opportunity to inspect and correct the processed data, as stipulated by the Dutch Personal Privacy Protection Act of 8 December 1992. Data can be passed on to third parties, unless the customer expressly objects to that.
14. All agreements between Lotto Zesdaagse Vlaanderen Gent and the customer are subject to Belgian law. Disputes ensuing from this agreement will be submitted to a competent court in the Hasselt (B) district. This also applies in the event of bills drawn on the customer.
